# Disclaimer

## to the VICTORY and friends! Meeting incl. ride out from 29-31.07.2022

**By my participation in the above-mentioned privately conducted meeting and a privately conducted motorcycle ride in this context (hereinafter collectively referred to as "Activities"), I expressly agree to the following regulations regarding the exclusion of liability, which I additionally confirm below by my signature:**

The participant is solely responsible for all his actions and his driving style, as well as the choice of the route before, during and/or after the participation in the above mentioned activities. This also applies if a third party leads the motorcycle tour as a tour guide. Participation in the above activities is at the participant's own risk and responsibility. The participant is also solely responsible under civil and criminal law for any damage caused by him and the motorcycle used by him.

The participant is aware that driving in a group must always take place within the framework of the applicable laws (cf. StVO, etc.). Violations of this (e.g. speeding, loss of roadworthiness due to technical deficiencies in the vehicle used, violations of the rules on safety distance, etc.) can lead to criminal consequences, loss of insurance coverage and exclusion from participation in the above activities.

The participant is aware of the risks of participating in the above activities, especially by participating in a motorcycle tour. Tour guide and/or organizer are in no way responsible for the personal safety of the participants and their belongings and insofar exempt from any liability for personal injury and/or property damage caused to participants and/or third parties in connection with participation in the above activities by accident, loss, influences of third parties, elementary influences and / or self-inflicted. Possible liability can only be assumed if an insurance company pays for any damage that may have occurred. In this case, the claims from the insurance are assigned to the injured party in the amount of the compensation sum to be paid, which, however, expressly does not imply any acknowledgement of guilt or agreement with the assumption of liability beyond this.

The participant assures to be in possession of a driving license valid for the participation in public road traffic in Germany, that the vehicle used by him is in technically perfect condition and is duly registered/insured (the StVZO applies).

The participant expressly declares to all persons connected with the private planning, organization and execution of the above mentioned activities his waiver of claims of any kind for damages incurred in connection with the execution of the above mentioned activities.

Furthermore, the participant assures that he/she is physically fit and able to participate in the above activities, that he/she does not have any physical ailments, and that he/she is not under the influence of alcohol, drugs or medication that could affect his/her ability to drive in any way. In this respect, the StVO also applies here.
